- 339 There were no Apologies
- 340 Cllr Cutmore declared an interest in item 347 a.
- 341 There were no questions from the member of the Public
- 342 District Councillor Vowles stated that he would make comment on the North Bridge and the Local Government Bulletins later in the meeting.
- 343 No Crimes have been Reported.
- 344 **The Minutes of the Meeting held on 25th June** were approved and signed by Cllr Tarbuck

345 Matters Arising from the meeting held on 25th June 2018

- a. District Councillor Vowles updated the meeting about the North Bridge in Oundle by stating that NCC are seeking planning permission to put in place a permanent width restriction of 2.4 metres, this will not be the usual plastic type but the type used on motorways, and a weight of 3.5 tonne along with permission for the correct type of mortar to be used. There is also a possibility of Oundle being made one way whilst the restrictions are in place. 2 engineers attended a meeting on Thursday 30th and were surprised as to the many representations from the neighbouring Parish Councils who attended. It has been suggested to put signs on the A14 and A1 with reference to the width and weight restrictions. There will also be a traffic survey on the amount of use the A605 endures on a normal day. At present there is no money available to carry out the work in repairing the bridge.
- b. The next meeting of the Tresham Garden Village is on Thursday 13th
 September at Deene Village Hall. With 4 votes to 3 it was proposed that the
 Joint Statement from both Benefield PC and Deene & Deenethorpe PC, which
 outlines the concerns both Parish Councils have, should be forwarded to
 Andrew Longley.
- c. The public meeting for Pathfinder II has been arranged for September 11th, all the landowners have been notified and Cllr Tadman will arrange for flyers for the residents.
- d. Cllr Tadman will contact PGR to see if they can complete the Wooden Gates.
- e. The Churchwarden is obtaining the correct permission to include Reginald Price's name on the War Memorial. Cllr Parkhouse agreed to make sure his name is read out on Remembrance Sunday.
- f. The Clerk confirmed that the new Website is live and she will continue to use both web-site to ensure that the new one is working. The new web-site address is www.benefieldparish.com there will also be a new e-mail address benefieldparishcouncilclerk@gmail.com
- g. The results from hiring the VAS from Deene and Deenethorpe PC have been forwarded to all the Councillors. Cllr Shatford has agreed to summarise the results for inclusion in the next village Newsletter.
- h. It was agreed that Street Light PL14, on the junction of the Glapthorn Road, should be repaired first. The Clerk agreed to contact E-on to place the order.
