## BENEFIELD PARISH COUNCIL

Minutes of the Parish Council Meeting held in the Village Hall on Monday 1st July 2019

- 432 **Apologies** had been received from Cllrs Cutmore and Parkhouse; these were accepted.
- 433 There were no **declarations of interest**.
- 434 There were no Members of the Public present.
- 435 Cllr Tadman introduced **County Councillor Annabel de Capel Brooke** to the meeting. Annabel gave a brief outline of her career in both ENC and NCC. She is spending time visiting schools and community groups. Funding is available from Augean for community projects. Annabel has recently had a tour of the Tresham Garden Village site and the planning applications is likely to be presented in the Autumn. Annabel is trying to arrange another meeting with Stephen Mold, the Police and Crime Commissioner, and the Chief Constable Nick Adderley.
- 436 **District Councillor Vowles** had informed the Clerk prior to the meeting that he had nothing to report.
- 437 **Crime Report** there had been several crimes committed in Lower Benefield on Saturday 22<sup>nd</sup> June/ Sunday 23<sup>rd</sup> June. Among items stolen was a garden strimmer, and a sit on lawn mower.
- The Minutes of the Meeting held on 20<sup>th</sup> May were approved and signed by Cllr Tadman
- 439 Matters Arising from the meeting held on 20th May
  - a. Cllr Tadman has a document to be e-mailed to all the councillors for their approval prior to it being placed on the website for the **Neighbourhood Plan**.
  - b. Cllr Tadman has been asked by Pathfinder II to provide photos of the work carried out so far. Cllr Tadman has distributed the Flood Warning signs along with locks. Cllr Tadman will also purchase the 2 door barriers before the next meeting. All this has been purchased from the **Pathfinder II funding**. Cllr Tadman agreed to contact Joanne Maddams with reference to clearing the gulley along the Weldon Road as the road flooded during the recent rain.
  - c. Cllr Tadman has investigated the **Wooden Gate Structures** and it was agreed that no further action should be taken at this moment in time. It was also agreed that due to the length of time that Highways are taking in repairing the damaged one in Upper that an insurance claim should be made, the Clerk to action this.
  - d. Cllr Pridmore agreed to provide the Councillors with details of any street lights which may require work on them before the onset of Winter. The Clerk confirmed that 3eAssets will provide some sort of light outside the Wheatsheaf. The Clerk also confirmed that she has received the new unmetered certificate from and will ensure that all the invoices are correct before raising payment.
  - e. Cllr Tarbuck reported that the 2<sup>nd</sup> **grass cut** had been completed, however due to the length of time it took for the completion because of his mower breaking down the villages look untidy. Cllr Parkhouse has agreed to talk to the contractor and it was resolved that the 2<sup>nd</sup> cut payment should not be sent until Cllr Parkhouse has agreed that he is happy with the contractor.
  - f. **Highway Issues** Sarah Barnwell has walked the roadside footpaths in Upper as suggested at the last meeting. Her findings were e-mailed to all Councillors prior to the meeting and "it has been noted a few places where hedges or other

vegetation was overhanging from adjacent properties, the landowners will be contacted by the Amenities Technician. There were some places with longitudinal cracking, but at this stage none of these present a trip hazard. Glapthorn Road seems to have a particularly narrow path. From a practical point of view, it might well be feasible to widen the path in Glapthorn Road. With regard to A427, it is unlikely that we could widen the paths beyond the current width as the properties abut close behind the path and the road has no spare width." It was agreed that Cllr Shatford to obtain a quote for RSOPA for an independent survey.

Cllr Pridmore has cut all the footpaths, Cllr Tarbuck thanked Cllr Pridmore. It was resolved that a letter should be sent to all the landowners reminding them that it is there responsibility to keep the bridleways cut, Cllr Tadman and the Clerk to action this.

## 440 Financial Matters:

- a. The Clerk confirmed there is currently £11914.79 in the Bank, which includes £819.69 Pathfinder II monies. The Clerk also reported that she has made is a VAT Claim for £277.62 with a further £825.88 claim to be made.
