- Apologies had been received from Cllr Groom which was approved.
- 786 There were no declarations of interest
- 787 There were no concerns raised by the members of the public.
- There was no report from North Northamptonshire Councillor for the East area.
- The minutes of the **Full Council Meeting held on Monday 14th November** were approved and signed by Cllr Shatford.
- Grass Cutting Tender it was resolved to accept the quote from Mowerman Grounds for 8 cuts at £2496 plus VAT.
- 791 **Benefield War Memorial -** The Clerk is obtaining quotes for a brass plaque with names of the fallen for Benefield War Memorial.
- 792 **Floral Carpet** held over to the March Meeting
- Coronation of King Charles III It was proposed that the planting of a tree at Coronation Crescent would be appropriate as the coronation is to be kept low key at the request of the King.
- Vacancy for Clerk It was agreed to advertise the vacancy on all the Parish Council notice boards, on Whatsapp, the Benefield Facebook page and word of mouth to any residents who may be interested.
- Correspondence from a resident regarding speeding traffic, defibrillator, dog fouling and rewilding/tree planting. The Clerk explained that Highways will not install any traffic calming on a designated A road. The matter of at least one defibrillator is on this agenda, dog fouling is an ongoing problem and with many residents against the installation of dog bins it will continue to be so. Again rewilding/tree planting is being considered under item 792/793. Cllr Shatford suggested that perhaps residents would like to set up a committee to tackle the speeding traffic issue with Highways.
