- Apologies had been received from Cllr Tarbuck which was approved.
- 802 There were no declarations of interest
- The following were raised by a member of the public The contractors have been leaving mud on the road and have been reminded by the planning enforcement officer of their conditions. There is a lot of basal growth around the tree on the junction with the Gated Road and the Oundle Road, could it be tidied up. This was granted and two members of the public will tidy it up. There is a problem with overhanging hedges on the footpath, the Clerk suggested that it is reported to Fix my Street. Could the following items be added to the next agenda, Dog Bins and Lost Footpath, this was agreed..

Mr Steve Lingley gave an outline of his work as Neighbourhood Watch Coordinator for Upper as well as his work within Crime Stoppers. The Clerk agreed to put his presentation on the Website and forward copies to the Councillors.

- The minutes of the **Full Council Meeting held on Monday 9th January** were approved and signed by Cllr Shatford.
- 805 **Benefield War Memorial -** The Clerk reported that there has been a site visit to the War Memorial in order to get the exact dimension for the plaques, one has to be circular and is now waiting for the quote.
- Floral Carpet No progress has been made, it was resolved to remove this item from future agendas
- **Defibrillator -** Cllr Cutmore has made a lottery grant application for this along with a seperate lottery grant application for 2 Vehicle Activated Signs.
- Coronation of King Charles III Cllr Groom informed the meeting that the Jubilee Committee has been disbanded. Mrs Groom would like to organise a traditional party for the children in the Cricket Field. The Clerk suggested that Mrs Groom look at the Coronation page on the NNC website to see if there is an appropriate grant available.
- Appointment of the New Clerk Cllr Shatford proposed that Mr Peter Bullock is appointed as the new Clerk on the same salary scale of LC1/9 £12.05 per hour as the current Clerk, to be reviewed in 3 months. This was seconded by Cllr Cutmore and agreed by everyone. Mr Bullock will officially take over on 1st May, the current clerk will conduct a complete and thorough handover. It was agreed that Mr Bullock should enrol for the following courses "Agendas & Minutes" and "New Clerks" run by Northamptonshire County Association of Local Councils (NCALC).
